THE CENTER IS OPEN YEAR-ROUND. IT PROVIDES CHILDREN WITH NUTRITIOUS, FAMILY-STYLE MEALS; THREE AGE-APPROPRIATE PLAYGROUNDS AND TEACHING STRATEGIES' PLAY-BASED CREATIVE CURRICULUM. TEACHERS ARE SUPPORTED BY OUR FULL-TIME QUALITY COACH, AND MENTAL HEALTH CENTER OF DENVER PROVIDES ON-SITE CLASSROOM SUPPORT AROUND TRAUMA-INFORMED BEHAVIOR MANAGEMENT.
