Position Title: Art Instructor

General Purpose:

As part of the Student and Family Support Program (SFSP), the Art Instructor position is an extension of the customized wrap around services for teen moms provided by Florence Crittenton Services to positively impact their education. The Art Instructor teaches Drawing/Painting 1 and Drawing/Painting 2 courses supporting the curriculum requirements for students attending Florence Crittenton High School. The ideal candidate will have experience teaching students of various ages and skill levels and possess a passion for social/emotional learning. This position reports to the Director of Student and Family Support Program.

Essential Functions:

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

- Plans and delivers engaging and interactive lessons for Drawing/Painting 1 and Drawing/Painting 2 classes, focusing on developing students' technical skills, creativity, and social/emotional development.
- Creates a positive and inclusive classroom environment that supports student learning and encourages artistic expression.
- Assesses student work and provide constructive feedback to help students improve their skills and reach their artistic potential.
- Utilizes Infinite Campus and Schoology to maintain Denver Public Schools grading and attendance policies.
- Attends Parent-Teacher Conferences twice yearly, communicates learning progress and strengths.
- Maintains classroom materials and equipment and ensures a safe and clean classroom environment.

Knowledge, Skills and Abilities:

- Ability to consistently promote, support, work, and act in a manner in support of Florence Crittenton Services' vision, mission, and values.
- Expertise in drawing and painting techniques, with a strong portfolio of personal artwork.
- Ability to design curriculum to meet the Colorado art education standards.
- Experience working with students of various ages and skill levels, including students who need language and Individualized Education (IEP) support.
- Excellent communication and interpersonal skills, with the ability to work collaboratively with other teachers and staff members.
- Strong organizational and time management skills, with the ability to effectively plan and deliver lessons and manage classroom materials.
- Efficiently manage email and calendar in Outlook

Education:

- Bachelor's degree in art education, fine arts, or a related field is required.

Experience:

- Two or more years of teaching experience in a classroom setting, preferably in a high school environment.
- Experience working in a classroom setting with an at-risk population is preferred.
- Experience working with culturally diverse populations is preferred.

Additional Requirements/Licenses/Certifications:

- Colorado Department of Education Teaching License is required
- Passing a criminal history background check will be required prior to the start of employment. Must be able to pass Colorado Central Registry and CBI criminal record checks and must have no prior convictions for child abuse, misdemeanors or felonies.
- Must have reliable transportation.
- Must have a valid driver's license.
- Bilingual in Spanish/English is strongly preferred

- This is a temporary part-time position which follows the Denver Public School (DPS) academic calendar, and observes the fall, winter, and spring breaks which are mandatory.
- This is a temporary part-time position with potential growth into a permanent position.
